4. Schedule for II Term

The Chairperson apprised the PTA members of the Schedule for II Term and it was conveyed that the same will be sent to the parents at the earliest.

5. Activity Report / Achievement / Workshop Report

The numerous achievements of the Gokulites were listed by the Chairperson and applauded by the PTA members. The Chairperson also informed the PTA members of the various activities and workshops conducted in August and September.

6. Revision of School fee for the A.Y. 2025-2026 & 2026-2027

The Chairperson presented the Management's proposal for a fee revision for the academic year 2025-2026 & 2026-2027 to the Committee. The audited statement of Income and Expenditure of three sections, estimated budget of the next two years was tabled. The statistics of students and staff strength was tabled for their perusal.

The procedure for the revision of school fee as per Section 9 of Fee Regulation Act was explained at length by the Chairperson. The factors considered while deciding the revision of fees was also tabled. They are as follows:

- Location of the school.
- Permanently unaided and self-financed school.
- Infrastructure & the facilities are made available to the students for qualitative education. Sufficient provision is being made for infrastructural facilities.
- Rent has been increased as per the Amendment of 2019
- Educational standard of the school.
- Expenditure on Administration and Maintenance.
- Provide and develop facilities
- Qualified Teachers (with regular up gradation through in-service training) and Non-teaching staff as per the norms and their salary components.
- Reasonable amount for yearly increments and half yearly D.A. revision.
- Expenditure incurred on students over total income of the school.
- Maintenance of reasonable surplus for qualitative development of students.
- Funds for exigencies

A. LOCATION & BUILDING: The Chairperson stated that our school is permanently unaided and self- financed school. It is a well renowned school and the infrastructure needs to be maintained.

Along with academics, physical and mental fitness has always been a priority. The enrolment and participation fees (for individual and team games conducted by CISCE), DSO, MSSA, MSDAA, AISM Sports and other co-curricular activities are borne by the school.

The faculty and the staff have to be paid in accordance with the 7th Pay Commission and Gratuity had to be paid for those who have completed 5 years in GHS & JC. There are many senior most teachers who retire and have to be paid gratuity.

F. MAINTENANCE & REPAIRS

- With 3000 plus students in school, regular maintenance has to be undertaken to ensure the safety of the students, teachers and staff and provide them with a conducive environment.
- Preventive maintenance ensures that the school infrastructure remains in good condition for years to come.

G. QUALIFIED TEACHING AND NON- TEACHING STAFF AS PER THE NORMS AND THEIR SALARY COMPONENTS.

- Stringent selection and hiring norms
- Staff Training, Professional Development
- Deputation to attend Cell Meetings for subjects

Based on the above mentioned factors, the Chairperson informed the members that the fee rise is 14% of the existing tuition fee {7000/--} for the next two years.

The tuition fee will be Rs. 8000/- per month {Eight Thousand Only} for the A.Y. 2025 – 2026 & 2026 – 2027.

As per the Fee Regulation Act 2011 {Maha Act No. VII of 2014}, point 6{3, 4} , the revised fee would be binding for two years.

After a brief discussion, the resolution was unanimously passed by the members of the Executive Committee of the PTA.
